COVER FOR MONEY INSURANCE

The policy provides the following cover:

1. Cash for wages and salaries against loss by any cause, including theft by the insured's own employees, whilst in transit until paid out, provided that all wages not paid on the same day as received will be covered against theft if secured in an approved safe or strong room.
2. Cash other than for wages and Salaries against loss by any cause, including theft by the insured's own employees, whilst being carried from the insured's premises to the bank or vice versa.
3. Cash collected by authorized employees of the insured from the time of receipt until delivered at insured's premises or to the bank.
4. Cover is limited to Ghana and the general particulars given in this prospectus are subject to the terms of the policy issued by the company.
